 Approval of previous Board meeting minutes November 1, 2022. Minutes stand approved as presented without any corrections proffered. Minutes approved

New Business:

- Quarterly Financial report: the budget v actual was presented some discrepancies were noted, John Howe will address with Source HOA
- 2022 IRS and Colorado tax returns John Howe filed both tax returns at no cost to the association.
- Insurance due July 7; John Howe completed the 14 page application and sent off to Mountain West our agent.
- Landscape maintenance, electric mowers, written policy: John Howe will work with Tami Huntsman to create a list of instructions on lawn and landscape maintenance for our contractor.
- Unit 17 condensation leak; Danny did some work on the interior of the space to no avail, John Howe called Victor, the roof installer, who is currently working with

Tami to address the problem.

 Driveway snow removal considerations: There have been continuing concerns about the frequent of driveway snow removal. Several events happened when there was much less than 2" of snowfall. Our agreement allows for 27 plowings any extras are paid at \$158@. We will be reviewing the total season costs when available.

- Special Projects: The Board was asked to review and prioritize what projects are to be address this year, the results are: 1. Gutter/heat cable repairs, 2. Driveway drain heat cable, 3. Gutter/downspout/heat cable installation on upper roof by unit 6/7, 2/3, 20/21, 22/23, 4. Repair driveway pot holes. Jeff Cieslik made a motion to approve the list seconded by Scott Strand, motion passed.
- Funding for special projects and reserve funding: Members discussed options
 for funding of special projects. John Howe made a motion to provide for a \$25K
 special assessment due April 28, 2023, motion failed for a lack of a second.
 After some continued discussion Jeff Cieslik made a motion to provide for a \$25K
 special assessment half payable on June 1., 2023 and the second half payable
 on August 1, 2023 seconded by John Vise, motion passed. A special
 membership meeting will be scheduled soon. There was not discussion or action
 on reserve funding.
- Part time maintenance assistant; John Howe recommended that Association look into hiring an hourly contract person to assist with the many tasks needed throughout the year. A search for such a person will be underway.
- Rewrite of HOA governing documents, John Howe discussed the need to rewrite all of our governing documents. No action taken.
